WHEREAS, one compressor on the Library's largest HVAC unit (HVAC Unit 1) became inoperable on or about July 25, 2022, which caused the Library to be unable to provide sufficient air cooling to seniors, young children, and others who were utilizing the Library in the middle of the heat wave occurring at that time; thus rendering the situation an emergency; and

WHEREAS, the Board recognized the emergency and acted immediately to repair HVAC Unit 1 ("HVAC Repairs");

NOW THEREFORE, the Board of Trustees hereby ratifies, *nunc pro tunc*, the declaration of the HVAC Repairs to have been an unforeseen public emergency as of July 25, 2002, and as referenced in NY General Municipal Law 103 as well as the Library's Procurement Policy and Regulation, and further ratifies the approval of Quinn and Feiner to replace two (2) compressors in the Library's HVAC Unit 1, at a total cost of \$24,997.
